- (ii) Certificate of Incorporation with Corporate Affairs Commission (CAC).
- (iii) Evidence of Company's Current tax Clearance Certificate for three years (2016, 2017and 2018).
- (iv) Evidence of Registration on the National Database of Contractors, Consultants and Service providers by inclusion of Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPP) Expiring by January, 2019.
- (v) Current Compliance Certificate with Nigeria Social Insurance Trust Fund (NSITF), expiring December 2019.
- (vi) Current Pension Compliance Certificate, in Compliance with amended Pencom Reform Act, 2014, expiring December 2019.
- (vii) Current ITF Compliance Certificate issued by ITF in Compliance with Section 6(2) of ITF. Amendment Act 2011, expiring December 2019.
- (ix) Audited Accounts for the three financial years (2016, 2017 and 2018).
- (x) Evidence of financial capability to execute the proposed service with certified bank Statement to buttress claim.
